## CUSTER SPORTSMENS CLUB 22PRS RANGE PRACTICE AGREEMENT

### 22 PRS PRACTICE PRIVILEGE POLICIES

1. Level 2 Front Range Safety check:
  - A. Does not get you back range access
  - B. May be given only after the 6 match minimum have been completed. Match fulfillment must be at least 3 22PRS matches and may then include 3 other matches front or back range.
  - C. Must be separate from the initial membership joining walk through.
  - D. Will require club membership and a range pass
  - E. Will be administered by the CSC CRO and other CEO approved personnel.
2. Front range 22PRS practice privilege must be recommended by the 22 PRS match director.
3. Level 2 back range safety check and/or back range access does not grant 22PRS Practice privileges.
4. Maintaining 22PRS Practice privileges from year to year will require 12 hours of volunteer time signed off. These hours can be met following the same requirements as fulfilling back range hours.
5. Anyone practicing 22PRS with targets not approved by CSC or 22PRS practice privilege may be immediately disciplined by the CSC on duty Range Officer or CSC CEO and may include loss of 22PRS practice privileges until reinstated by CSC Board of Directors vote.
